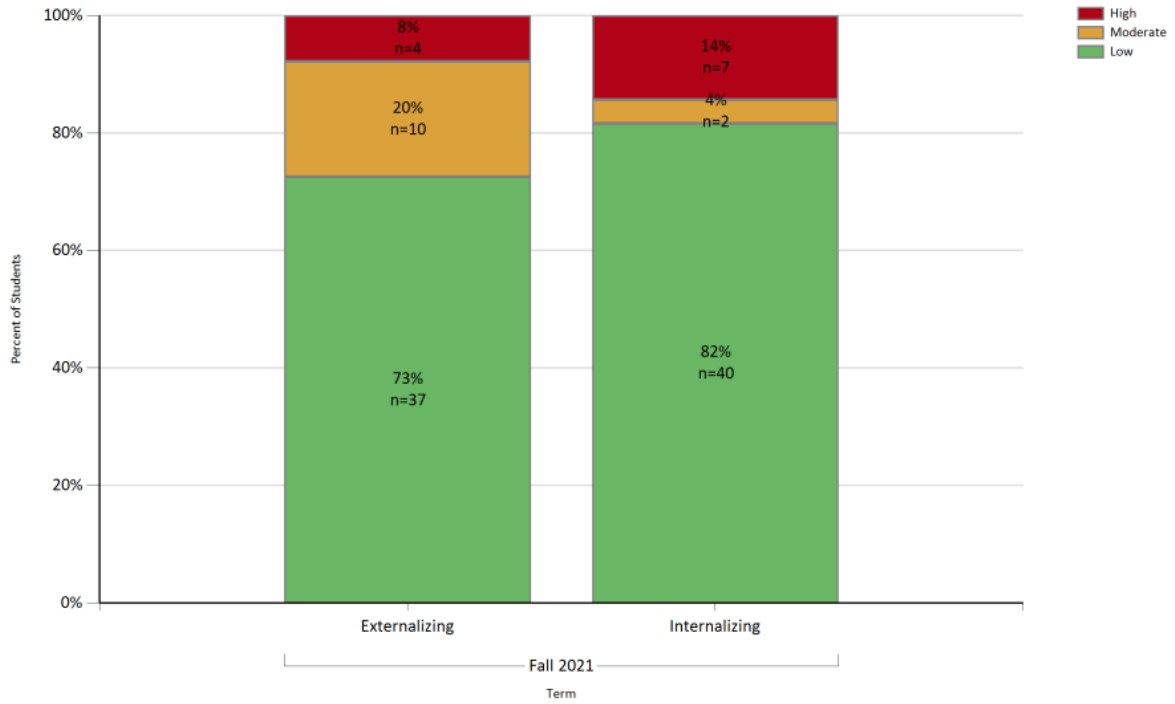

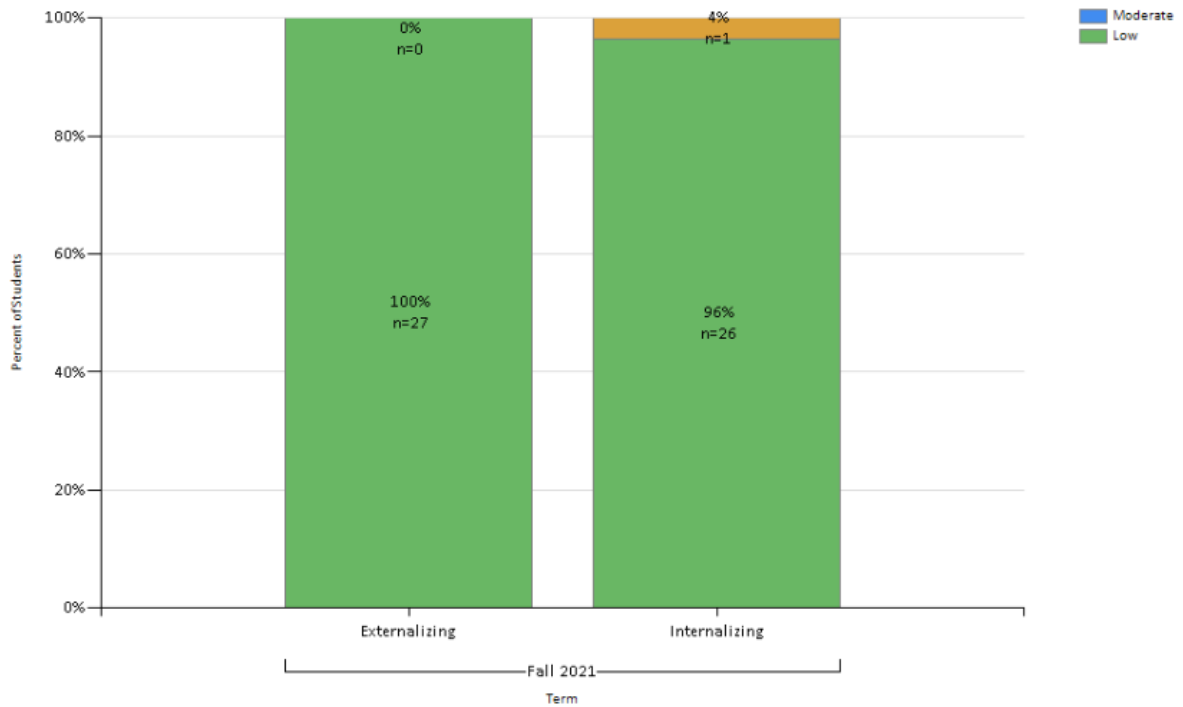

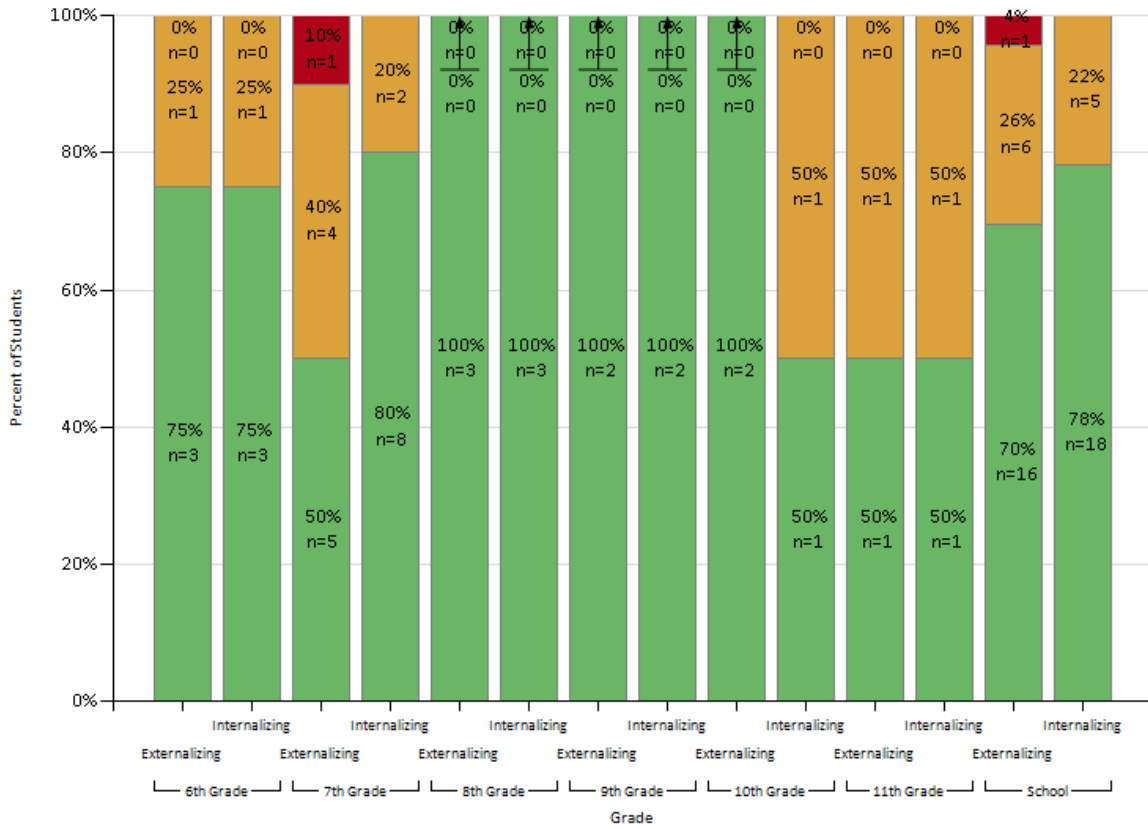

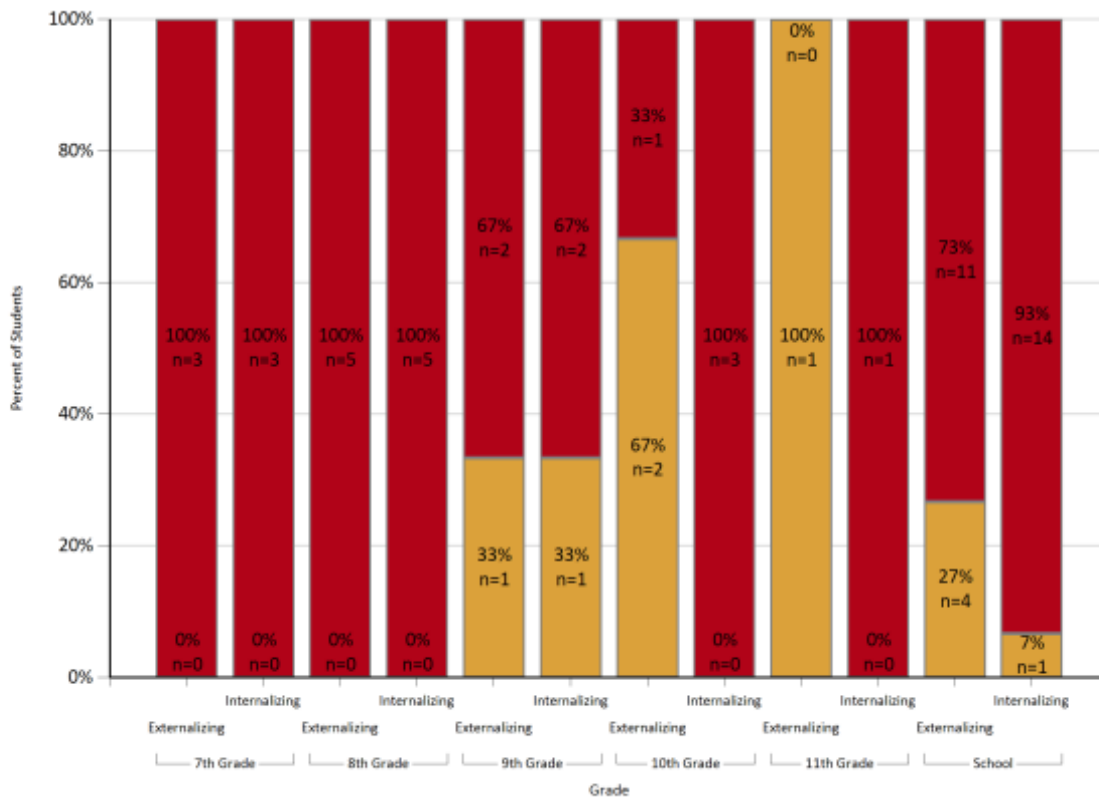

Summary

Along with these academic deficits, students also tend to have a list of behavior issues and in school concerns surrounding them due to the traumas they have experienced prior to enrollment. The data shows that the students we work with continue to require additional support specific to what is offered in the Residential and Juvenile Justice programs. The standards earned as well as credit count is a testimony to the hard work of the Lighthouse Academy staff in the Wedgwood, Eagle Village, Waalkes, Pier, and Ottawa JDC Programs. It is critical we continue to grow and learn how to accommodate the emotional needs of our students by utilizing standards effectively with special populations.
